All members should utilise the Union's Legal Assistance scheme if they are involved in any type of accident (or contract any form of industrial disease), whether it occurs in the workplace or outside of work. In respect of any other employment issues a member must go through his/her shop steward and full time official who will, if necessary, refer the member to the Solicitors.

Our Solicitors at Francis Hanna & Co are able to represent members or their families in respect of Road Traffic Accidents, Accidents in public places, Criminal Injury Claims, Medical Negligence Claims or any other type of situation where either you or a family member wish to make a claim or are facing legal concerns, such as being sued. 
