In order to stand for election as a TSSA Representative, prospective candidates **must**:

- be a member of TSSA;
- be employed by London Underground;
- be in a grade/band for which TSSA has collective bargaining rights
- have a minimum of six months service with London Underground.

Prospective candidates **must** also be supported by a nominator and a seconder who must :

- be a member of TSSA;
- be employed by London Underground;
- be in a grade/band for which TSSA has collective bargaining rights
- have a minimum of six months service with London Underground.

Prospective candidates should complete the nomination form in full. It is particularly important that TSSA has up to date contact details for reps. Failure to complete all parts of the nomination form may result in the nomination being declared invalid.

Please be aware that this nomination is to cover a vacant position on a temporary basis until the role can be advertised properly.

You do not need to re-apply for the role when it is advertised as this form will be taken as your nomination.

However, you need to be aware that should one or more persons also express an interest in the advertised role, you will need to take part in a competitive election process.
