Merseyrail Update

Pay - no increase for 2021

TSSA has received letters from the company stating that there will be no pay increase for 2021 for nearly all staff except for staff on salaries at or below £24,000 per year, where an increase of £250 will be paid from 1 April 2021.

Similar pay freezes have been applied in train operating companies that have franchise agreements with the Department for Transport. Given that unlike those, Merseyrail has not received the government financial assistance that the DfT franchise companies have, it has already undertaken several rounds of redundancies, and therefore this has come as no surprise.

It is recognised that the biggest concern for our members at present given the massive downturn in revenues is to hang on to their jobs. To that end, TSSA is keen to work with both Merseyrail, Merseytravel and the Liverpool City Region to ensure that passenger numbers and revenue recover, and Liam Robinson will be meeting with the TSSA Executive Committee on 27 April 2021.

TSSA reps needed

TSSA currently has only one rep in Merseyrail - Keith Sheppard. Since the departure of Julie Stamper, TSSA has no reps in Liverpool Rail House - no reps for either clerical of management grades.

It goes without saying that in these uncertain times it is vital that the staff are represented. Anyone who wishes to discuss how they can play an active part in building TSSA in Merseyrail is asked to email Steve Coe (the TSSA paid official responsible for Merseyrail) at coes@tssa.org.uk.
