First Day's Proceedings

1. Appointment of Tellers & Voting Clerks

Tellers and voting clerks were appointed. Tellers processed one item during Conference.

2. Minutes of 2017 Annual Conference

The Minutes of the 2017 Annual Conference were presented. The Minutes of the 2017 Annual Conference were agreed.

3. Announcement of Election Results

The Scrutineers report on the elections for the various offices, delegations etc. were adopted. (See Minute 107 on Page 82).

4. President's Address

The President's Address was delivered by Mick Carney and warmly received by Conference.

5. Remembrance of Deceased Colleagues

Conference observed a brief silence in remembrance of deceased collegues.

6. Stewards' Report on Attendance

Final attendance figures show that 58 delegates attended representing 39 Branches & SOGs, and with members of the Executive Committee, Standing Orders Committee and the paid staff, there were a total of 66 present. There were also several visitors throughout Conference

ADDRESS BY JEREMY CORBYN MP, LEADER OF THE LABOUR PARTY

This was followed by an opportunity to ask questions.

7. Middle East (Item 7)

That this Conference notes that the Joint Comprehensive Plan of Action (JCPOA), an international agreement to avoid nuclear proliferation in Iran, was agreed in July 2015, after months of negotiation. This was in exchange for removal of economic sanctions, and was ratified by the five permanent members of the UN Security Council, plus EU member states.

Conference also notes that Syria and Iran applauded the agreement and the declaration by them, in November 2017, of military defeat over Islamic State in Levant (also known as ISIS).

Conference is aware that, whilst JCPOA does not address human rights and the testing of ballistic missiles in Iran, the deal is a step in the right direction for the nonproliferation of nuclear weapons and towards peace in the Middle East.

Conference is concerned that the US President, Donald Trump, decided in October 2017 that he would not sign the certification required under the Iran Nuclear Agreement Review Act, saying that the scheme was flawed. Conference is also concerned that the US President is at odds with international players involved as well as his own advisors.

Conference instructs the EC to continue to seek assurances from the Government and the Foreign Office that it will take a pro-active part in foreign affairs and within the UN, and that international relations are important to us all, not just America alone.

8. Freedom for Öcalan Campaign (Item 8)

That this Conference is appalled at the plight of Abdullah Öcalan, a Kurdish nationalist leader and a founder member of the Kurdistan Workers' Party (PKK).

Mr Öcalan was arrested by the Turkish Intelligence Service with support from the CIA in Nairobi in 1999, was subjected to an unfair trial, granted no right of appeal, and has been incarcerated in a Turkish jail for over 18 years, in contravention of three articles of the European Convention of Human Rights. He was originally sentenced to death, however this was commuted to life imprisonment owing to Turkey abolishing the death penalty in 2002.

The Freedom for Öcalan Campaign was established in April 2016 to build support for the release of Mr Öcalan and to campaign for the Kurdish community to be allowed full participation in democratic processes, to be free from discrimination and to be free to choose their own leaders and representatives. Ocalans's work in Kurdish feminism is particularly poignant in this, the 100th Anniversary year of Women's Suffrage in Britain and Ireland.

Conference believes that the appalling treatment of Mr Öcalan must be opposed and highlighted, that he must be released from prison immediately and that the rights of the Kurdish people to self determination must be promoted.

Conference congratulates the General Federation of Trade Unions (GFTU) for holding a Kurdish Cultural Festival at its hotel in Quorn on 30 July 2017. Supported by the GFTU, this festival also included as its sponsors the Freedom for Öcalan Campaign and several other Kurdish organisations in the UK. Conference agrees to promote any other similar events to Association members.

Conference agrees to affiliate to the Freedom for Öcalan Campaign, to support the work of the organisation and to highlight the plight of Abdullah Öcalan and that of the Kurdish community.

Conference is also appalled at the recent attacks by Turkish forces on the Kurdish People's Protection Units (YPG) forces based in northern Syria. Conference is appalled at the Turkish government calling the YPG terrorists, even though the Syrian Kurds have been the most effective resistance against ISIS terrorists in that region, while also slowing attempts by Syrian government forces to retake the Kurdistan region of Syria. Conference pledges support in principle for Kurdish independence, and condemns the hypocrisy of the Turkish President and his government forces' brutal and unhelpful involvement in the complex civil war in Syria. This is taking place together with substantially increased erosion of human rights throughout Turkey over the past two years, incarcerating domestic Kurdish elected politicians, journalists and thousands of civic opponents.

9. **Venezuela** (Item 9)

That this Conference notes the serious impact of US sanctions imposed this year on the Venezuelan economy and on the lives of the Venezuelan people. This, of course, is not the only country in this region of the world that suffers from US sanctions, notably Cuba for example.

Conference remembers the role played by the US in providing cover for the attempted right-wing coup against the Venezuelan Government in 2002 and also remembers US involvement and interference in other countries such as Nicaragua in the 1980s.

Conference therefore calls on the British Government to condemn the current US interference in the internal affairs of Venezuela and the US attempts to undermine a Government that has, over the past two decades:-

- (a) built three million affordable homes;
- (b) transformed levels of literacy;
- (c) brought health care to the poorest, and
- (d) cut infant mortality by 40%.

Conference condemns the UK right-wing media bias and notes the effective blackout of news on the recent very positive election results, where the Government party won 18 out of 23 Governorships.

Conference continues to support the Venezuelan (Solidarity Campaign) and Cuban Solidarity Campaigns and, to show further support for countries in this part of the world against US oppression, instructs the EC to affiliate to the Nicaragua Solidarity Campaign.

10. **Low Pay** (Item 10)

That this Conference wholeheartedly applauds the stand taken by the Bakers, Food and Allied Worker's Union and the young McDonalds workers against the scourge of low pay. Such a resounding victory is a step in the right direction, but it remains just a small step.

Conference congratulates Jeremy Corbyn for his speech at the 2017 TUC which said that the "epidemic of low pay, which is closely tied up with insecurity at work, ruins people's lives, leaving workers and their families locked in poverty." Jeremy Corbyn also highlighted the fact that the pay gap at firms such as McDonalds - whose chief executive is paid 1,300 times more than ordinary staff - was symbolic of the "deep inequality and injustice that scars our society".

Conference thanks all those who demonstrated outside McDonalds on 14 February 2018, who exposed the company's practice of low pay, zero-hours contracts, and bullying and harassment by poorly paid and low paid managers.

Conference recognises that young people continue to face discrimination in all aspects of modern life from the denial of housing benefits to a lower minimum wage, and for many the dream to get on the property ladder will remain just that: a dream.

Railway companies are not exempt from this discrimination:-

- (a) low paid 'apprenticeships' with no guarantee of work at the end;
- (b) managers who fail to follow the terms of apprenticeships, and

(c) mundane work offering nothing in the way of development, are just some of the issues.

Conference congratulates the EC for the foresight to allow Future TSSA the funds to relaunch in February this year, but recognises that this support will need to be ongoing if Future is going to succeed.

Conference instructs the EC to bring the terms of this motion to both the TUC and the Labour Party and calls upon the support of both of these bodies.

Conference commits the Association to supporting our young people. They are the next generation of union members.

11. **Housing** (Item 11)

That this Conference opposes privatisation of Housing Associations (HAs) and the associated risk to residents in their properties.

Conference recognises that such privatisation is solely a means to remove the HAs' combined debts of £70 billion from the Public Sector Borrowing Requirement. This would make HAs as unaccountable as private landlords, and remove the rent level

guarantees that all HAs must currently give to rental tenancies and sharedownerships.

Conference instructs the EC to work with other relevant bodies:-

- (a) for strong opposition to such privatisation and,
- (b) should that privatisation take place, for an incoming Labour Government to commit to bringing HAs back into the accountable public sector.

12. Housing (Item 12)

That this Conference is concerned that the use of the term 'social housing' is distracting government and voters from the desperate need for new council housing.

Nearly all new social housing, whether rented or purchased, is now provided through the distorted market for housing. It is therefore only provided where the local planning authority has the right requirements in an up to date adopted Local Plan, and where substantial profits (often around 25%) can still be guaranteed for the developer and landowner after all other costs have been taken into account. Due to the Conservative Government's changes, the other avenue for the provision of social housing directly by Housing Associations has effectively been cut dead.

Worse than this, even when provided, the discounts for purchase or the Government defined and misnamed 'affordable rent' at 80% of the local housing market rents, mean social housing is actually still unaffordable for the majority on lower incomes, and even many on middle incomes in more expensive parts of the country. Council housing, on the other hand, is in the ownership of an elected and accountable public body and provides housing as needed for people who cannot afford social housing rents. Much of the latter is paid by Housing Benefit so the taxpayer is funding property owners' profits, money that would be better spent on housing that was in public ownership.

Conference calls on the EC to ensure that the Labour Party, including the Scottish & Welsh Labour Parties, have a commitment in their next manifestos to:-

- (a) a major council house building programme across the United Kingdom;
- (b) place a duty on all councils to provide, over the next 10 years or less, a sufficient supply of new council housing (along with other forms of housing, including a reformed and more affordable version of social housing) to tackle the affordability crisis for all sections of the population, and
- (c) provide access to the necessary funding and/or Government borrowing to allow them to do this.

13. Fire-Related Deaths (Item 13)

That this Conference is appalled by the sharp increase in fire-related deaths across London. In 2016 there were 46 fire-related deaths across the capital, up from 33 the previous year. And of course, being 2016 based, these figures do not include the Grenfell Tower tragedy.

Conference believes that the blame for this increase in deaths lies at the feet of Boris Johnson, the Tory Mayor of London from 2008 to 2016 who, in 2014, closed 10 fire stations with the loss of over 550 fire fighters. One of these closed fire stations was Knightsbridge, just 3.5 miles from Grenfell Tower. Conference believes Johnson should hang his head in shame.

Conference further acknowledges that we now have a Labour Mayor, who has been in place for 2 years with a resounding mandate, backed handsomely by the Association. Conference believes the time has come for a review of Johnson's failure of fire provision across London and for the safety and welfare of Londoners to once again be put first.

Conference instructs the EC to bring sentiments of this motion to the attention of the London Mayor's office.

14. National Insurance Fund (Item 14)

That this Conference is concerned that the UK state pension languishes at the bottom of the list of state pensions in European economies despite the fact that the UK economy measured by GDP is the fifth largest in the world.

Conference notes that the National Insurance (NI) Fund, after allocating a fixed proportion for funding of the NHS, provides for the state pension plus a range of unemployment and other benefits and is funded by employers and employees through National Insurance Contributions.

Conference further notes that over many years the NI Fund has been in surplus in almost all of those years, even after allowing for a prudent margin for unexpected calls on the Fund, for example a sudden rapid increase in unemployment. However, over the same period governments of all political persuasions have, through the Debt Management Office, borrowed the Fund surplus to reduce the overall cost of government borrowing.

Conference instructs the EC to campaign for an increase in the state pension to be funded through the surplus in the NI Fund. Conference further instructs the EC to campaign for control of the NI Fund to be taken away from the government and the Treasury and transferred to independent commissioners with a statutory duty to utilise the whole of the Fund balances, after setting aside a modest contingency, to pay for increases in NHS spending, state pensions and other benefits.

15. Social Care (Item 15)

That this Conference notes the disconnect between hospital discharge into the community and the levels of suitable social care. This can delay return to work of an employee and also brings extended separation within older and retired families, often linked to unaffordable cost.

Conference notes that there is a need for the wider railway and transport industries and others, to extend and develop the funding for the provision of access to convalescent homes and retirement homes such as the Railway Convalescent Homes, Woking Homes and the Railway Housing Association for use by current and former transport staff and their families.

Conference also calls on the EC to work with the Almshouse Association to identify those set up to provide accommodation for people connected with the transport industry and to seek opportunities to get the transport industry to work with such almshouses to develop and financially support them in their provision of accommodation for retired transport staff.

Conference instructs the EC to ensure that such provision be made more widely known to staff and retired staff and their families.

16. **Environment** (Item 16)

That this Conference is concerned that not enough is being done to link together many of the major problems facing the world and thereby not recognising the opportunity of an holistic solution. The following list shows some of the issues needing to be solved:-

- (a) increasing atmospheric concentration of carbon dioxide (C02);
- (b) the wholesale destruction of the world's rainforests;
- (c) rising sea levels;
- (d) rising average temperatures;
- (e) increasing incidence and severity of floods, famines and storms;
- (f) growth of violence over control of resources, whether or not presenting as political or religious causes, and
- (g) the resultant rise in refugees and economic migration and exploitation of them for criminal gain.

The underlying causal factor is water, where and what kind it is. What is needed is concerted action to redirect its availability to where it is required.

Conference, therefore, instructs the EC to campaign with all relevant bodies to concentrate a significant proportion of the UK foreign aid budget, working with UN agencies, the African Union and charities like Water Aid etc, on a major project to:-

- (i) pipe sea water to those parts of Africa (and other countries as appropriate) that are in desperate need of water supplies and irrigation, and
- (ii) employ solar energy in recipient areas for desalination to provide fresh water for agriculture, industry and domestic use, plus salt and other chemicals as a by-product.

The benefits of this globally significant project are:-

- 1) limiting sea level rise by direct extraction of water;
- 2) enabling equatorial and tropical agriculture by growing trees over crops as proven in the Americas, thereby enabling populations to feed themselves;

- 3) absorption of atmospheric carbon by growing the trees required (over very large areas), which would also promote clouds and rain with consequential beneficial effects on global temperatures;
- 4) reduction of flood risk by vegetative retention of water and soil fixation;
- 5) reduction of famine risk due to greater crop dependability;
- 6) reduction of risk and severity of storms due to lower temperatures;
- 7) removal of migration pressure due to dependable food supplies and ability to prosper at home;
- 8) reduction of financial and political costs of responding to the problems of migration;
- 9) increased local tax revenues from settled populations to fund better infrastructure, communications and prosperity; and
- 10) improved political climate creating opportunities to include those currently using violence to create maturing businesses and job opportunities without the perceived need for criminality.

This is a big project, but at a relatively low cost compared to ongoing wars and the need to respond to uncontrolled climate change. The time has come for a FRESH approach to WATER.

17. Environment (Item 17)

That this Conference notes the steadily growing evidence that the cost of electricity generated from renewable sources continues to fall. Conference is also aware that the deal between the UK Government, EDF and the China General Nuclear Power Group for the construction of the proposed Hinkley Point C nuclear power station is inordinately complex and protects the contractors at the expense of future British taxpayers and electricity consumers.

Conference therefore calls for:-

- (a) urgent development of an exit strategy for the contracts for Hinkley Point C, with the intention of cancelling this unnecessary project;
- (b) the cancellation of any other planned new nuclear power stations; and
- (c) a renewed commitment to the Campaign for a Million Climate Jobs, including a comprehensive strategy of conservation and demand reduction measures and a policy of developing renewable energy generation including onshore and offshore wind, tidal and geothermal.

Conference instructs the EC to raise this issue in the TUC and the Labour Party.

18. **Environment** (Item 18)

That this Conference notes with concern the use of glyphosate to control lineside vegetation. Glyphosate is marketed as Roundup by the US agrochemical giant Monsanto, and is used extensively to kill weeks on ballast and on structures such as bridges. Although glyphosate degrades naturally and is widely considered to be less harmful than other herbicides, it has been linked to a range of health issues in humans and wildlife. A study commissioned by the World Health Organisation in 2015 concluded that the chemical was 'probably carcinogenic to humans'. Norway, Denmark, Sweden, Sri Lanka, El Salvador, Brazil and India have already banned the use of Roundup. French President Emmanuel Macron has ordered a ban on the use of glyphosate in France 'as soon as alternatives are found, and within three years at the latest'.

Conference calls on the EC to lobby Network Rail, London Underground and other transport authorities to fund research into the feasibility of using safer methods and

products which will not damage the environment and wherever possible to adopt safer methods for vegetation control.

19. Menopause (Item 19)

That this Conference believes the Association can and should do more to help our sisters who are going through the menopause. In Sept 2017, over 70% of all UK workers were women, all of whom will experience the menopause.

Some of the symptoms associated with the menopause include hot flushes, palpitations, night sweats and sleep disturbance, fatigue, poor concentration, irritability, mood disturbance, skin irritation and dryness. For most women this happens between the ages of 45 and 55 although a minority experience these symptoms in their early thirties. These hormonal changes and symptoms can last from four to eight years.

Conference recognises that many of our sisters in the rail and bus industries work in safety critical roles yet none of the companies in Ireland or the UK take this into consideration, nor do they have a menopause policy. Conference believes it is time they did.

Conference therefore instructs the EC to drive a programme through our reps and paid officials to engage with the industries that they negotiate with, to fight to deliver a policy that will not only benefit the female members of this Association but a policy for all women workers. Conference also asks the Irish Committee to develop a similar programme.

That this Conference notes that people with gambling addictions are often suffering from a hidden mental illness. Many do not even realise they have gambling compulsion. It can result in devastating consequences for the individuals and their loved ones around them, including loss of their home and even death. Yet there is no cap or limit on how much you can gamble: within an hour, it is easy to gamble away your life savings and place yourself in considerable debt.

It is not easy to know if a colleague is under the compulsion or addiction of gambling but such people are in need of help and our Association should endeavour to make members and reps aware. There is so much temptation currently out there, such as casinos, betting shops, slot machines etc, with all of these simulated again on-line; yet there is nothing but a voluntary Set of Regulations for these firms to comply with and these do not cover checks into ability of the person to pay nor is there a limit to how much a person can gamble.

Conference instructs the EC to ensure members are made aware of gambling issues and to provide reps with details of best advice and where to get help for anyone who approaches them with gambling debts or addiction.

Conference also instructs the EC to heighten the awareness of problems associated with gambling to our sister unions, the TUC and the Labour Party. Conference calls on the EC to use its influence and lobby the TUC and Labour Party to encourage any suitable bodies, political or otherwise, into reviewing the current gambling problem and possible introduction of a cap on the various gambling activities.

Conference therefore instructs the EC to affiliate to the EDA and other European bodies of similar nature that the EC deem appropriate.

That this Conference notes that UK citizens currently enjoy the right to equal health care across other EU member states as long as they apply for and carry a European Health Insurance Card (EHIC). The EHIC covers treatment on the same basis as would apply to a resident of the relevant country, either at a reduced cost or, in many cases, for free. The EHIC also covers the treatment of pre-existing medical conditions.

For the EHIC to remain in force the UK would have to stay in the single market at Brexit and it is not negotiable outside that framework. The UK would need to negotiate bilateral reciprocal agreements with the member states to secure the same concessions as EHIC.

For many UK disabled people who have to travel abroad as part of their employment, this is an essential benefit. The fact that our pre-existing conditions are covered without added costs is of great benefit. For many disabled people, foreign travel can be a very costly affair and getting private travel or medical insurance can be impossible, with many insurers refusing to cover pre-existing health conditions and disabilities and some only with the added cover the EHIC provides.

Going on holidays for the general public is as simple as getting a travel insurance policy from their local supermarket. For disabled people it is much harder, there are so many exclusions and exceptions and EHIC offers a security blanket and reassurance although EHIC does not cover repatriation.

Conference therefore instructs the EC to:-

- (a) campaign for a like for like provision in any reciprocal agreements matching EHIC provision in case of a hard Brexit taking us out of the single market, and
- (b) raise awareness of this issue to disabled members and the general public via social media and other publications.

Conference is concerned that the reduction in TfL's operating grant has caused drastic cuts to bus services, using the excuse that Crossrail services absorb excess capacity. However, the cuts are happening before services start, and this will affect our members' futures.

Conference is also alarmed that the opening of Crossrail in December 2018 has been linked to the removal of bus services along Oxford Street to encourage pedestrianisation of this main shopping thoroughfare.

Conference notes that pedestrianisation of main shopping streets such as Oxford Street, and many towns, such as Oxford, and suburbs in London, are often welcomed by retailers and pressure groups, such as Living Streets, as helping making shopping streets pleasant places to walk and citing reduced levels of pollution. Conference also notes, however, that this takes buses away from the very objective of bringing passengers to shops, especially the elderly, disabled and generally those with restricted mobility, and that through passengers will suffer longer journeys by being taken on longer, diversionary routes, acting as a disincentive to using buses.

Conference instructs the EC to object to the cutbacks of routes in this fashion and ask the Mayor of London to review the role of the bus in servicing Oxford Street and the proper integration of public transport in London.

Conference also instructs the EC to lobby the DfT for a restoration of TfL's operating grant as a benefit to mobility around London.

Conference notes that TfL has announced what it has called a 'pause' on the development of new trains and associated infrastructure for the Northern and Jubilee lines on London Underground.

TfL stated, on its website in August 2014, that 'Alongside new modern signalling systems, the additional trains will help LU meet the challenge of London's growing population - set to increase from 8.2m today to around 10m by 2030 - by increasing capacity in central London on the Jubilee line by 13% and on the Northern line by 25 per cent.'

The construction of these additional trains and associated upgrade work will now not take place, however the demand on our transport system will continue and, for the foreseeable future, increase.

Conference believes that London is a world class city, however it is one of the few cities that do not fully fund its mass transportation system from the public purse. London faces all the challenges to its transport infrastructure that other cities do; greater demand, ageing rolling stock and life-extinct technology. London's increasing air quality problems present a related challenge.

It is not possible to deliver the transport system London needs and at the same time continue to slash funding.

Conference calls on the Executive Committee to lobby the London government, central Government and the Labour Party to secure proper public investment in increasing the capacity and sustainability of our essential public transport.

Conference considers there is no place for private sector competition in building control and supports the return of all building control functions to adequately funded local authorities.

Conference believes it is vital that trade unions are recognised and full public accountability is maintained for public projects and services and calls for this to be reflected in national and local government procurement policies and other relevant areas of public policy.

Conference calls for a full and transparent system for the management of all publicsector contracts.

Conference believes that the best way to plan the future infrastructure, both nationally and locally, in the public interest is to reverse the deregulation, privatisation and contracting out processes of the last 20 to 30 years.

Conference instructs the EC to raise this issue in the TUC and the Labour Party.

Conference calls on the EC to produce a report to branches within six months, including recommendations on what the future Political Fund contribution rate should be, and to bring the necessary Rule alterations to the 2019

Annual Conference for decision.

That this Conference notes that Network Rail has responded to the collective equal pay grievances raised by the Association by introducing a revised pay structure for Band 1-4 employees called Your Pay. The principle of this change was to create a fairer pay structure and to provide a transparent and fair structure.

Conference notes that the Association has supported the development of a fairer pay structure but the company implemented the new structure without addressing the Association's concerns, particularly in regard to a fair mechanism to progress through the pay range and that the new structure was not considered to have addressed all of the equal pay concerns.

With the introduction of Your Pay, the Association has successfully won significant pay rises for hundreds of employees who were being paid lower than the newly assessed minimum rate for each job. Many challenges remain, however, including staff with identical job titles but identified with different pay ranges and therefore different rates of pay.

Conference notes also that many cases remain of employees who carry out identical jobs while paid very significantly different salaries. The differences in are not linked to experience, competence or qualification; in many cases the only difference is the employee's gender.

Conference therefore instructs the EC to initiate a campaign to improve the existing Your Pay structure including:

- (a) an improvement for those on common job titles to have the same pay ranges;
- (b) to identify and support opportunities for equal pay claims in order to put pressure on the company to make improvements to the pay structure, and
- (c) to eliminate current unacceptable pay differentials.

That this Conference is aware that British pensioners have amongst the least adequate state pensions in Europe and that this position is expected to continue over the coming years, as revealed by the Pensions Policy Institute in October 2017.

A separate report by the investment bank UBS, which compared the retirement outlook for a 50-year-old woman in 12 major cities across the globe, found that a woman in London can expect just 40% of her current income in retirement. This was the same as in Hong Kong and just one place above the lowest ranked city, Taipei in Taiwan. Singapore at 73%, Sydney at 72%, Paris at 68% and Milan at 67% were the top four cities.

Conference notes that Labour Party pension policies are superior to those of the Conservatives but believes that a new assessment needs to be made, with consideration given to raising the employers' share of pension contributions. Conference therefore instructs the EC to progress this with all relevant bodies.

Conference believes that municipalities have the best local knowledge to plan and operate bus networks within their boundaries and to liaise with neighbouring authorities to provide cross-boundary and cross-border travel to serve the needs of their residents, visitors and workers. This is currently frustrated by the terms of the Bus Services Act 2017.

Conference recognises that provision of such bus services requires suitable and sufficient funding, to be at advantageous interest rates so as not to be a burden on local municipal expenditure.

Powers should be given to enable all municipal bus companies to borrow money, at favourable rates for investment, from the Public Works Loan Board.

Conference therefore accepts that the Bus Services Act 2017 is not fit for purpose, and needs either overhaul or replacement, and therefore calls on the EC to join with relevant bodies to work toward a publicly-owned, comprehensive network of affordable bus services across the UK.

Conference also calls on the EC to provide an annual report to members on or about the time of Annual Conference on work during the preceding year toward these objectives.

national and local initiatives to our members and to send representatives to sit on local Stand Up To Racism committees.

86. Tax Avoidance, Evasion and Havens (Item 83)

That this Conference notes Item 30 (Minute 18) at 2017 Annual Conference and welcomes its partial inclusion in the 2017 Labour Party Manifesto For the Many not the Few.

Conference notes that company tax avoidance and evasion are encouraged by pressure on big business to maximise profits and payments to shareholders.

The shift over the last 30 years away from a more caring and community-based society, towards one where self-interest is the norm, also encourages individuals to avoid and evade tax. The richer they are the bigger the rewards to them and the bigger the loss to society.

Corporate and income taxes are major sources for Government spending on schools, NHS and house building, and Government cuts to these have had a disproportionate negative impact on the vast majority of the population who are not rich.

Conference calls for a public inquiry to look into tax avoidance and evasion, including:-

- (a) how the Government works with British overseas territories, Crown dependencies and others to control tax evasion and avoidance;
- (b) how to change the law to what would be considered moral by the majority in the UK;
- (c) how the Government stays ahead of big business which will use expensive lawyers and accountants to get around new laws, and
- (d) consideration of HMRC resources to allow detection and recouping from tax avoidance.

Conference considers that if the current Government refuses a public inquiry then the Labour Party, with the assistance from trade unions with members in the HMRC, should develop relevant policies.

However, it would be wrong to say all in the garden is rosy. Momentum was set up as a grass roots campaigning organisation. It was Independent minded and free flowing: that indeed is what attracted many people, especially the young, towards it. (Now its head has been elected to the NEC and there have been question marks over the handling of a democracy exercise a couple of years ago.)

Conference understands the need (for Momentum to be Labour supporting and to hold Labour values but urges it) to bring progressive change to the Labour Party and Momentum, so as not to lose its independent spirit, the very spirit which attracted so many young people in the first place, the spirit which includes everyone.

Conference, therefore, instructs the EC to withhold immediately any payment to Momentum or give any officer support to Momentum until such time as a full consultation has been undertaken with the wider Association membership through Branches and Divisional Councils.

Conference is alarmed that the Scottish franchise is one of the most heavily subsidised franchises in the UK, while the operators are making consistent annual operating profits of between £10-£20 million.

Conference is concerned by Abellio Scotrail's failure to provide a reliable, costeffective public transport service in Scotland. There is a public appetite for an end to private companies taking profits abroad, and people want a publicly owned railway in Scotland where money is re-invested in infrastructure in order to reduce delays, cancellations and skip-stopping.

Conference calls upon the EC to campaign with other unions and put pressure on the Scottish Government to terminate the Abellio franchise and take Scotland's railway into public ownership.

- b) air and missile strikes against the Assad regime by Britain, the US and France in breach of International Law; and
- c) Turkish military incursions into Syria targeting Kurdish fighters who have defeated 'Islamic State' militants.

Conference notes that since the initial rush to arms supporting Trump's warmongering, there has been complete inertia on the part of the British government to seek a justified settlement.

Conference believes:

- i. that further missile and air strikes by the US, Britain and France will increase the loss of innocent lives whilst doing nothing to bring an end to the appalling conflict in Syria;
- ii. that anyone responsible for chemical attacks must be brought to justice in The Hague following an investigation by the Organisation for the Prevention of Chemical Weapons;
- iii. that Britain must play no further military role in this conflict without the support of a United Nations resolution; and

iv. that the international community must now urgently relaunch a diplomatic initiative to bring the conflict in Syria to an end through a political settlement and ensure that all necessary humanitarian support required is provided.

Conference instructs the EC to use every available opportunity to make the views contained within this motion known to the Labour Party, TUC and related organisations and to seek to influence their policies so that they chime with ours.

That this Conference notes the announcement on Tuesday 5 June 2018 by Transport Minister, Chris Grayling of the government endorsement of a 14 billion plus expansion and third runway for Heathrow airport which flies in the face of air quality concerns in London and the climate emergency we have to deal with as well as the destruction of local communities when new homes are needed.

Conference notes that this calls for new/ urgent action to stop this potential environmental catastrophe and flag up the false environmental and economic claims and call on the EC to:-

- a. launch an immediate campaign for Labour MPs 'No' vote;
- b. campaign to ensure the Labour Party commits to a sound environmental policy which includes opposing Heathrow and airport expansion;

- c. campaign to get the TUC to oppose Heathrow and airport expansion and make sure unions are not buying the false promises of variable numbers thousands of new jobs;
- d. campaign to get both the Labour Party and the TUC to commit to alternatives to destructive construction and expansion projects for short term gain, including just transition away from energy intensive jobs, including One Million Climate Jobs (including rail over short haul flights, increased public transport, retrofitting housing and building much needed sustainable housing, more jobs in agriculture, energy democracy and renewable energy projects which can create both the employment and environment desperately needed for a sustainable 21st century infrastructure;
- e. ensure that Campaign Against Climate Change and Climate Jobs campaigns are built into the activity plan of the Campaigns Committee, and that these are actively promoted to TSSA members, and
- f. organise a Climate Jobs event at the Tolpuddle Martyrs' Festival in 2019.

Conference believes that these protestors - many of them refugees from areas inside the state of Israel - have the right to return to their homes and lands, as enshrined in UN General Assembly Resolution 194.

Conference calls for an immediate end to the slaughter, for Israel's withdrawal from the occupied territories, for an end to all discrimination inside Israel, and for progress towards a just and peaceful future for Palestinians and Israelis.

Conference notes the political stance taken by the Jewish Voice for Labour organisation, which is remarkably close to the position taken by this union, in support of Palestine and the Palestinians, over the past years.

Conference calls for an end to arms sales to Israel and urges the widest possible support for vigils and demonstrations called around the UK.

Conference asks the EC to seek to send a delegation to meet with the foreign office to make our position clear, and to encourage the TUC to send a delegation to Gaza.

That this Conference is of the view that there is no justification for continuing to maintain the Labour Party's parliamentary group "Labour Friends of Israel" (LFI), and the affiliation to the party by the "Jewish Labour Movement" (JLM). Conference is unaware of any other named state which has a "Labour Friends of..." and are unable to identify any special need or demand for this particular affiliation when there are so many other democratic socialist countries which might merit such special attention, and especially as there is also a "Conservative Friends of Israel" to which most Conservative MPs belong.

The clear function of these groups has been to maximise support for Israel's policies including the occupation of land in Palestine, which the UN has declared should be independent. The JLM has maintained a similar role in defending Israeli policies and the principles of Zionism at all costs. The most recent actions by these groups have been false accusations of anti-Semitism levelled at Labour Party members who are clearly not racist, and have even targeted several Jewish members of the Labour Party for suspension and expulsion for daring to criticise Israeli Government policies and actions. The determining factor in recent claims has been to ensure the embarrassment and removal of Jeremy Corbyn as the new leader of the Labour Party, and it is regrettable that the Labour Party responded with unjustified disciplinary actions.

There are Jewish groups who oppose the propaganda of these two organisations, including many who are in the Labour Party such as "Jewish Voice for Labour" but who have been ignored or sidelined.

Conference therefore calls on the Labour Party to terminate their association with these two named organisations, LFI and JLM, as soon as possible and to encourage support instead for the Jewish Voice for Labour, Jewish Socialist Group, Jews for Justice for Palestinians, and others who support the demand for an independent Palestine and an end to the Occupation.

We note the explanation given by the Assistant General Secretary in circular 119/18. However we believe that conference is entitled to a full explanation of why this has happened, because branch had wished to ask a question on the status of the political fund.

Conference calls upon the General Secretary to make an urgent report to conference to explain why this situation has arisen.

101. TSSA ORGANISATION (Item E10)

That this Conference notes with concern the increasing incidence of Circulars and other correspondence emailed from TSSA Head Office not being received by some members, branches and SOGs. Conference is further concerned by reported repeating problems with email communications, and messages being blocked by mail servers and 'spam' filters. This is illustrated by the fact that many members of the Retired Members' Group did not receive the newsletter distributed in April 2018, notably among those with a BT internet mail account. Conference notes that the distribution of TSSA News On The Go, via 'Mailchimp', seems to have fewer problems.

102. Composite - Steel and international trade (Item E14 and E18 Composite)

That this Conference deplores the announcement by Trump on 31st May 2018 to introduce trade tariffs on the USA's closest trading partners. So much for our special relationship. This further exposes the folly of Cameron to call for a referendum on Brexit without fully understanding the consequences and once again exposes the deplorable decision to close the British Steel Redcar steelworks.

This criminal decision threw thousands of skilled working class men and women onto the scrapheap. A short sighted decision which placed a complete reliance on imported foreign steel with a complete disregard to the impact on communities left behind to suffer.

Conference demands that all necessary steps are taken by the European Commission and UK government to protect UK steel including Port Talbot/Llanwern plants which are particularly affected due to the high percentage of special type steels that they export to the USA.

The consequences of this Trump decision will not just affect the steel industry but will have far reaching impact across British business as whole, business that may well not have its European allies to rely on in the future.

Conference condemns this isolationist decision by Trump and calls upon the Labour Party to not only do likewise but give a commitment that Tory decimation of industries across Britain will be reviewed as a priority of an incoming Labour government.

Conference therefore calls on the EC to promote and support the Together Against Trump National Demo on Friday the 13th of July.

103. Transport Policy (Item E13)

That this Conference notes the announcement by the Rail Delivery Group on 8 May 2018 that the industry is seeking a "Root and Branch Reform" of rail fares. Transport Focus is to carry out a public consultation to formulate proposals in this respect.

Conference is concerned that an increasing number of fares are available only via the various digital platforms or offer a discount if booked on line.

Conference is also concerned that split ticketing can often result in cheaper fares between two destinations, and is specifically mentioned in the consultation as an anomaly of rail fares.

Conference instructs the EC to participate in this consultation exercise and to pursue with all relevant companies and organisations the principle that all fares should be available at ticket offices at the same level as those offered on line.

104. TSSA Organisation (Item E17)

That this Conference is dismayed that the deadline of 21 April for submission of amendments to TUC Disabled Workers' Conference was missed, as was the earlier deadline for submission of motions. Delegates had not been asked for submissions as had been previous Head Office practice.

Conference believes it would be extremely helpful to branches, SOGs and elected delegates to external bodies if TSSA Head Office could send out a list of the closing dates for motions and amendments to all external conferences as well as the closing dates for any nominations that can be made. This would ensure that these dates are not missed in future.

Conference believes that it is important that TSSA does not miss its opportunity to have its voice heard and therefore calls on the EC to consider sending this information out in a timely manner.

Conference further believes that all conference correspondence should be acknowledged by e-mail or a written receipt.

105. **BREXIT** (Items 89, E4 & E8 Composite)

That this Conference notes:

- 1) Deep division within the Tories, resulting in the Government failing to articulate a vision for post-Brexit Britain. As a result of this, the Cabinet on 02 May 2018, was unable to agree a position on future customs arrangements with the European Union (EU) once the proposed transition period has elapsed;
- 2) By 08 May 2018, the Government had suffered 14 defeats in the House of Lords on its EU Withdrawal Bill, making the Bill almost unrecognisable from what the Tories had previously squeezed through the House of Commons;
- 3) On 11 May 2018, The Independent reported that post-Brexit, millions of European Economic Area workers currently in our country, will need work visas. Those

- workers would then face deportation for going on strike, thus weakening trade unions and workers solidarity;
- 4) On 13 May 2018, The Observer reported that student organisations representing almost a million young people in our country's colleges and universities were joining forces to demand a referendum on any final Brexit deal;
- 5) Negotiations on a Brexit deal remain mostly deadlocked and are very unlikely to reach a conclusion that works for ordinary people so long as the Tories lead them;
- 6) The Labour party has said that its six key tests with the addition of a customs union must be met in full before a Brexit deal gains its support.

Conference reiterates its:

- a) Opposition to a no deal Brexit;
- b) Support for the continuation of free movement of people between Britain and the 31 other countries within the European Economic Area;
- c) Opposition to Britain simply becoming a rule-taker like Norway;
- d) Support for working with trade unions and sister parties of the Labour Party to create a Europe for the many;
- e) Opposition to the creation of a hard border in Ireland.

Conference is deeply concerned that the rights fought for by the trade unions, including health and safety protection, equal pay for women, the right to paid holiday and holiday pay for part-time workers, are under threat and the Government may erode workers' rights when the European Union Withdrawal Bill converts EU law into UK law but without MPs voting on them. Under so-called 'Henry VIII powers', employment legislation could be altered without consultation.

Conference also believes that when the Brexit referendum took place, no one knew what the consequences would be, because no one knew on what terms we would leave the EU. Conference feels that for democracy to function effectively, the people have to know what they are voting for (or against) and since we still do not know what the final deal will look like, we certainly cannot have known that when the referendum took place.

Conference welcomes Jeremy Corbyn's response to the Government's announcement on 2nd March that "Theresa May's only clear priority today seemed to be to tie the UK permanently to EU rules which are used to drive privatisation and block support for British industry."

Conference welcomes:

- i. The Labour Party's position on Brexit continuing to evolve in the direction of what was agreed last year by our Annual Delegate Conference;
- ii. The Party's commitment to vote down any deal which doesn't meet its six tests and also doesn't deliver a post-Brexit customs union with the EU;

iii. That there is now clear red water between our Party and the Tories over Brexit.

Conference therefore urges the leadership of the Labour Party to vote against the Government over Brexit at every turn to precipitate the end of Tory rule. Conference also instructs our Executive Committee (EC):

- To continue lobbying and campaigning in line with the wishes and instructions contained within the comprehensive Brexit policy positions agreed last year by our Annual Delegate Conference and those contained within this motion;
- To lobby the Labour Party, TUC and related organisations to ensure no support
 is given to any Brexit agreement which makes us a vassal state. This includes
 retaining our voice and influence during any agreed transition period by
 continuing to attend the Council of Ministers and also through the retention of
 our full complement of MEPs during this time;
- To lobby the Labour Party and campaign for ordinary people to have the final say through a referendum on any Brexit deal which is agreed by Parliament so that the British people can make an informed decision regarding their EU membership, once they are aware of the deal on offer. If this is then rejected, Britain must remain a member of the EU. If this is the case, our EC must continue its proud record of always standing up for our members by opposing any legislation emerging from Brussels which goes against the interests of working people. Our union will never be sycophants for those elements within the European ruling class who want to create a neo-liberal Europe. Instead, our EC must continue standing shoulder-to-shoulder with our sisters and brothers across the EU to create a Europe for the many;
- To campaign for 16 and 17 year-olds to be given the vote in a referendum on any Brexit deal agreed by Parliament;
- To work with the Labour Party and the TUC to scrutinise changes made during the Brexit process, and to take justifiable action to protect the interests of our members and all workers;
- To continue and maintain the Association's long and proud record of critical support of the UK's membership of the European Union;
- To actively seek to change the EU ethos to supporting working people and their workplace rights.
