#### **Amendments**

Not more than one amendment may be submitted by any one Branch/SOG. These should be e-mailed to supportservices@tssa.org.uk and soc@tssa.org.uk with the subject line 'SDC Amendments'. Because of difficulties with handling post during the pandemic, Branches and SOGs should e-mail their amendments rather than posting them to Head Office.

Were possible Branches and SOGs forwarding amendments to the SOC should also supply the **Mover** and **Seconder** to their amendment so these can be added into the Final Agenda.

Amendments must be received no later than Wednesday 26th January 2022

E-mailed amendments must clearly be authorised by two different Branch/SOG officers, this should be done by making sure that two Branch/SOG are included in the e-mail (e.g. sent by one officer, with another officer copied in).

Although a form for submission of amendments is included with this Circular, SOC will not require the use of this form as long as the information required is included in the email.
